1. Objectives of the MOU :

The objectives of this Memorandum of Understanding are given as under:

- To promote Communication between The Departments of English of S. S. S. K. R. Innani Mahavidyalaya, Karanja (Lad) and Vidya Bharati Mahavidyalaya, Amravati in mutually beneficial areas.
- To Improve English Speaking ability of the students and place in to subsequent jobs.
- To build better foundation for livelihood through work.
- To develop teamwork and skill technology.
- To guide the students for better opportunities.

2. Proposed Modes of Collaboration :

The Departments of English of S. S. S. K. R. Innani Mahavidyalaya, Karanja (Lad) and Vidya Bharati Mahavidyalaya, Amravati propose to collaborate as given under:

- i. To promote Academic Experts from the both institutes for organizing Academic Guidance Talks, Seminars, Workshops and Conferences for the students and the staff members.
- ii. To organize Seminars, Workshops and Conferences in collaboration.
- iii. To make available research center for the research scholars and the teachers to work on M. Phil. And Ph. D.
- iv. To promote the students for Campus Interviews.
- v. To avail the facility of English Language Laboratory to the students.
- vi. To make English learning and teaching more effective and interesting.

3. Agreements for Programme Collaboration:

The collaboration for every programme undertaken by the parties hereunder shall be initiated by the signing of a separate programme agreement between the parties, which will describe in detail as given under:

- a. The nature, scope and schedule of the programme collaboration.
- b. The form of the programme collaboration.
- c. The estimated cost of the programme collaboration shall be distributed together with the amount of funding, if any, to be received from third parties.
- d. Other provisions as may be mutually agreed upon, including provisions covering the consequences of default or termination by a participant, term, arbitration of disputes and applicable law.

4. Confidentiality :

For a period of three years from the date of disclosure, each party will agree to consider information as confidential. Both the parties agree not to disclose any information of the bank which may be in written or tangible form.

5. Non-exclusivity:

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular training agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

6. **Terms and Termination :**

This MOU, unless extended by mutual written agreement of the parties, shall expire 5 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any programme Agreement, Confidentiality clause as referenced in clause 6 above, or any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

7. **Relationship :**

Nothing in this MOU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.




