3. AGREEMENTS FOR COLLABORATION:

Every collaboration undertaken by the parties hereunder shall be initiated by the signing of a separate Skill agreement between the parties, which will describe in detail as given under:

- a. The nature, scope and schedule of the training collaboration.
- b. The form of the training collaboration.
- c. The estimated cost of the training collaboration together with the amount of funding, if any, to be received from third parties.
- d. Other provisions as may be mutually agreed upon, including provisions covering the consequences of default or termination by a participant, term, arbitration of disputes and applicable law.

4. CONFIDENTIALITY :

For a period of three years from the date of disclosure, each party will agree to consider information as confidential. Both the parties agree not to disclose any information of the bank which may be in written or tangible form.

5. NON-EXCLUSIVITY:

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a particular training agreement, the participants may agree to limit each party's right to collaborate with others on that subject.

6. TERMS AND TERMINATION :

This MOU, unless extended by mutual written agreement of the parties, shall expire 5 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the obligations of the participants under any Training Agreement, Confidentiality clause as referenced in clause 6 above, or any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

7. RELATIONSHIP :

Nothing in this MOU shall be construed to make party a partner, an agent or legal representative of the other for any purpose.





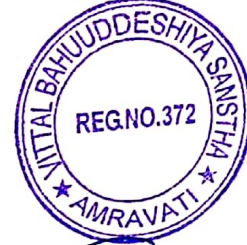
